

AUTHORIZATION OF PUBLICATION

In accordance with the Decree of 25 May 2016 updated with the Decree of 26 August 2022 establishing the national framework for training and the procedures leading to the award of the national thesis diploma, theses defended at University Claude Bernard Lyon 1 must be submitted in their electronic version. The version presented during the oral defense complies with the original version.

The University is subject to the obligation of depositing doctoral theses in the application STAR. The thesis is reported in the SUDOC catalogue, from www.theses.fr, and in the local catalogue, as well as in the portals for reporting and disseminating theses, which can be consulted freely on the Internet and indexed by search engines. This description applies to all theses, including confidential theses.

Online publication of the thesis with free access is subject to the author's permission in compliance with the provisions of the intellectual property code. If the author has not given his or her authorization for online publication, and unless there is a confidentiality clause, the thesis will be accessible only to the members of the university community.

In case the thesis has been granted a confidentiality period, its publication is postponed to the end of the confidentiality period. Confidentiality period is granted by the University and the specific form must have been signed by all parties before the defense.

This authorization of publication is not exclusive. The author reserves the right to a simultaneous publication of the thesis by the means and under the conditions of his choice, subject to compliance with the provisions of the intellectual property code.

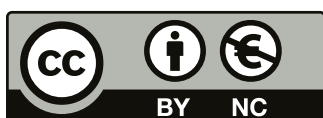

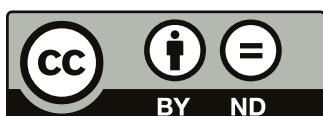

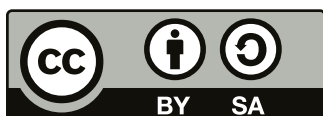
